WHEREAS, the bidder has submitted all required documents in accordance with the Local Public Contracts Law and the Board's specifications; and

WHEREAS, the Board Secretary/ Business Administrator has certified that funding for this project is available,

NOW, THEREFORE, BE IT RESOLVED by the North Hanover Township Board of Education, County of Burlington, State of New Jersey that the total bid in the amount of \$5,723,500.00 is accepted and that the contract for Renovations - Phase II at the CB Lamb Elementary School is awarded to Dandrea Construction Company.
